# **National Campaigns**

### 1. Say NO to Experimental Seabed Mining

We mobilised 24,000 signatures in 2012, for a public petition to the PNG Government to apply the precautionary approach to seabed mining and impose a moratorium on the "experiment" while more studies are conducted on social and environmental impacts that ensue. And we continue to maintain pressure on all stakeholders that there is a serious cause for pause.

## 2. Cancel the Special Agriculture Business Leases and stop Customary Land Grabbing

After the establishment and completion of a Commission of Inquiry into land grab, we continue to actively engage people in calling for the cancellation of illegal leases over customary land and forest clearance licenses, which encourage illegal forest clearances.

#### 3. Stop the Stealing of Public Funds

We actively apply pressure through blog articles, press releases, public awareness and public events for enforcement of the findings of all official inquiries into stealing of public funds since 2009.

To ensure that the spirit and intention of Papua New Guinea's National Goals is reflected in all its laws, resource development projects, government policies and decision making.

# Papua New Guinea's National Goals and Directive Principles

The National Goals of Papua New Guinea provides 5 clear developmental guidelines for Papua New Guinea's socio-economic development.

Successive PNG Governments have not recognised the PNG WAYS and systems in decision-making that would lead to a homegrown development path based on PNG Values. Unrestrained Capitalism has been promoted instead – a model of development that divides, exploits and rules in an attempt to increase profits at the expense of people. Unrestrained capitalism goes against the National Goals of Papua New Guinea.

#### **Our Position**

We believe; a more equal distribution of wealth will help improve education and health care. Greater localization of decision-making will increase accountability, help improve the distribution of wealth towards quality education and health care; Promotion of local industries will improve wealth distribution and help retain control of customary land. Our campaigns are therefore designed around what we believe are the 5 main pillars of just and fair society, which are described in the following narratives:

#### 1. Localization

Corruption is thriving and bad decisions are being made because decision-making and expenditure is concentrated in Waigani where there is no accountability. We demand greater regional autonomy and localization of decision-making and expenditure to give local people and institutions a voice and improve accountability and transparency.

# 2. Equal Distribution of Wealth

There is a deliberate and systematic theft of our resources by foreign corporations and the outrageous accumulation of wealth by a few greedy individuals. We demand our government to establish a well resourced ICAC and no new resource projects until a full analysis of current operations and measures to ensure transparent, fair and equal distribution of costs and benefits

#### 3. Land

Unscrupulous foreign corporations and greedy Papua New Guineans are stealing land, breaking up communities and depriving them of their sustenance using corrupt officials, lies and violence. We demand the protection of customary and state land. There must be no further land alienation or land registration schemes.

#### 4. Local Industries

Successive governments have discriminated against local industries by failing to provide protection, proper infrastructure and technical and financial support. We demand our government recognize our future is an economy based on Papua New Guinean people and values. The government must actively promote local skills and industries by providing protection, investment and incentives.

#### 5. Education and Healthcare

The healthcare and education conditions for staff, students and patients are shameful and appalling. We demand the government provide access to free quality healthcare and free quality education for all.
